The Scottish Government also liaises with the UK Government as regards the on-going development of EU legislation on company law. Responsibility for 'floating charges' in Scotland is devolved and the Scottish Government is currently considering how best to take forward Part 2 of the Bankruptcy and Diligence etc (Scotland) Act 2007, which modernises the law on floating charges and provides for the establishment of a Scottish Register of Floating Charges.
